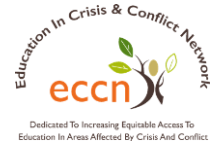
As its name implies, the Rapid Education and Risk Analysis (RERA) process is designed to provide USAID program planners and managers with a fast and “good enough” situation analysis of the

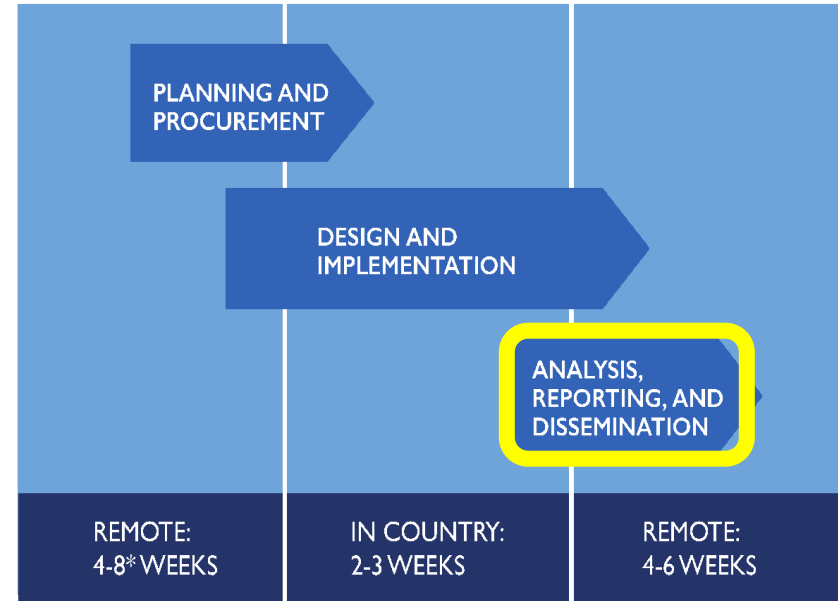
- Learn the key steps in completing and disseminating the RERA Final Report, including stakeholder engagement and maximizing quality, buy-in, and action.

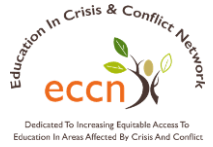

STAKEHOLDER VALIDATION MEETINGS



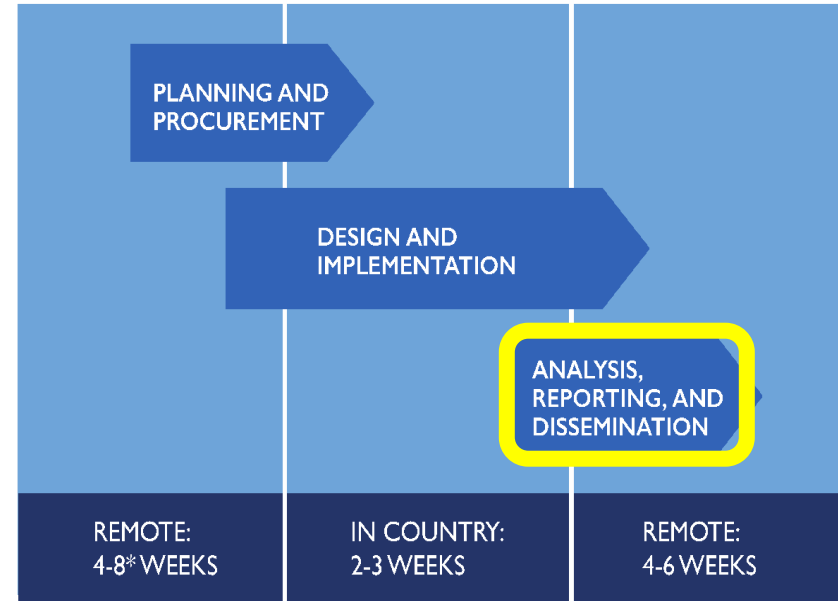
- In-country, with key informants, government officials and international and national stakeholders

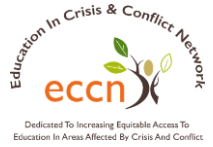

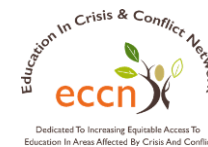
RERA FINAL REPORT: Content



- Not a “data dump”
- Around 25 pages, excluding annexes (data)
- A true executive summary (2-4 pages)
- Explain methodology, challenges, limitations
- Tell the story for busy people



RERA FINAL REPORT: Process



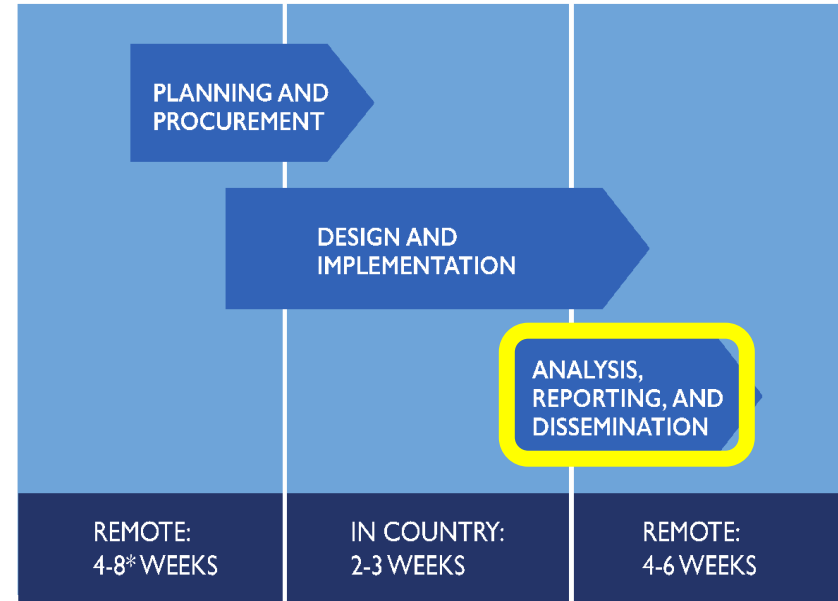
- Confirm Final Report expectations with USAID Mission
 - Validate preliminary conclusions and recommendations:
 - with MoE
 - partners and stakeholders
 - USAID Mission
- Hold end-of-fieldwork debrief with the USAID Mission
- Participate in VTC with USAID Mission and Washington
- Finalize Final Report remotely
